



### THE FUND

Saskatchewan Chicken Industry
Development Fund (SCIDF) was created in
1999. The purpose of the fund is to
develop the chicken industry through
research and development and promotion.
SCIDF is run by a separate committee of
Chicken Farmers of Saskatchewan (CFS)
members who determine where and to
whom the funds should be allocated. To
date the SCIDF committee has helped fund
over 30 research projects, many of which
are housed at the University of
Saskatchewan, it's also donated to various
non-profit organizations throughout our
province.

# THE COMMITTEE

The SCIDF fund is managed and operated by a jointly elected and appointed sub-committee under CFS, the following were it's 2019 Committee members: Patrick Keet (Chair), Rudy Martinka (Vice-Chair), Nelson Keet, Henry Van Ee (CFS Board Representative), and Glenn O'Hara (AAFC representative).

This past year SCIDF provided total funding in the amount of \$473,327. This amount included \$422,546 towards research projects and poultry extension. The remaining \$82,291 went towards promotional projects, scholarships and expenses. The Chicken Farmers of Saskatchewan continues to be a national leader in advancing poultry research and development in Canada.

# REVIEW OF SCIDF RESEARCH PROJECTS 2019

Research Projects Continuing in 2019\*

Dr. Gomis - Delivery of CpG ODN motifs - \$40,000.00

Dr. Koester - Glowing Bacteria to Monitor and Control Salmonella in Poultry, \$20,000 over 3 years.

Dr. Gomis - Control of variant Infectious Bursal Disease Virus (IBDV) infections in the broiler chicken industry in Saskatchewan, \$120,000 over 3 years.

Dr. Gomis - Control of Avian Reovirus infections in the broiler chicken industry in Saskatchewan, \$120,000 over 3 years.

Dr. Dar - In ovo and post hatch characterization of nonantibiotic alternatives to antibiotics for control of bacterial infections in chickens, \$60,000 over 4 years

Dr. Gomis - Control of Necrotic Enteritis in the broiler chicken industry in Saskatchewan, \$120,000 over 4 years.

Dr. Sharif - Towards Control of Avian Influenza Virus Transmission, \$45,000 over 4 years.

Dr. Wang - On-farm trials to validate encapsulated essential oils to control necrotic enteritis in broilers, \$25,400 over 2 years.

Dr. White - Use of emerging technology to detect and predict antimicrobial resistance in the Saskatchewan food supply, \$36,000 over 3 years.

### **SCHWEAN-LARDNER**

Assessing on-farm euthanasia in poultry.

- \$60,000 total funding

#### DAR

Optimization (standardization) of proven in ovo effective non-antibiotic agents for control of yolk sac infection and mortality in young broiler.

- \$80,000 total funding

#### **KOESTER**

In ovo vaccination platform to reduce salmonella and campylobacter bacteria in poultry.

-\$60,000.00 total funding
